### Commercial Treater Application Recommendations

1. Please refer to Excalibre Technical Sheet, included, for specific recommendations. 2. Fill the pre-mix tank with the appropriate amount of water to achieve detailed coverage on the seed. 3. Use only non-chlorinated water. 4. Measure and apply Excalibre for Soybeans at the rate of 0.05 ounce per 140k of seed. Please refer to the Excalibre Technical Sheet, included, for specific recommendations. 5. Pour measured amount of Excalibre into premix tank liquid and apply to inoculate desired amount of soybean seed. 6. Use Extender for Excalibre to achieve desired extended on-seed shelf life. 7. Maintain agitation.

### Excalibre with seed treatments and Extenders

1. Excalibre may be used in combination with approved, commercially applied seed treatments. 2. Extender for Excalibre must be added to achieve an extended on-seed planting window. 3. For a complete list of compatible seed treatments, instructions for use of approved polymer extenders, and recommendations "days on-seed planting window," please contact your Excalibre representative at 1-877-617-2461.

### RECOMMENDATIONS FOR ADVERSE CONDITIONS OR NEW "VIRGIN" SOYBEANS FIELDS:

When any of these conditions are present, Agrauxine Corp. highly recommends at least a double (2x) rate of a combination of inoculants: • Soil has not hosted the specific legume for more than three (3) years • Soil pH is less than 5.8 (the pH should be adjusted by liming prior to inoculation) • Soil pH is more than 8.5 • Organic matter is less than 1.5% • Drought or flooding has occurred • Topsoil exceeds 80°F • Soil erosion • Use of soil treatments and chemicals injurious to soil bacteria and inoculants.

Under any of the conditions above, follow these recommendations: A. Apply a 1X rate of Excalibre Soybean no more than 30 days prior to planting.

B. Additionally, applying at planting, a 1X rate of America's Best Inoculant<sup>®</sup> formulation: ABI Sterile Peat.

**STORAGE INSTRUCTIONS:** Contains living micro-organisms. Store packaged in a cool dry place between 40° and 77°F and keep closed until use. Use inoculant before expiration date and only use on specified legume seed. Protect inoculant and inoculated seed from direct sunlight.
