Shake Before Use

Moka can be used on all open field or greenhouse crops by foliar or drip application (preferentially foliar). Follow good agronomic practices, soil test reports, tissue analysis, or follow the recommendations of an agronomist when using this product.

Apply in 5 to 100 gallons of water per acre to ensure adequate foliage coverage. Do not apply undiluted. Apply only as directed.

Compatibility

Moka is compatible with most fungicides, insecticides and herbicides.

Application Instructions

Shake Moka container thoroughly before use.
Add the required amount of water to half of the mix tank.
Add the required amount of Moka and mix thoroughly.
Continue agitation during application.

Application Rate

Apply 1 quart per acre every 10 to 15 days after fruit, nut or seed set.
