DIRECTIONS FOR USE:

This product is intended to improve nitrogen fixation.

Shake well and use the opened container within 72 hours. For good seed coverage under most seed treatment applications, MegaPack inoculant should be either co-applied with other compatible liquid seed treatments or diluted with NON-CHLORINATED WATER. Agrauxine Corp. generally recommends that the total volume of liquid applied, including inoculant, compatible seed treatments and water, not be less than 2.5 fl. oz. (by volume) per 140k seed for good seed coverage.

THIS CONTAINER TREATS 500 x 140k Units Soybean Seed.

MegaPack is an all liquid system designed for use in a liquid tank mix in commercial seed treatment systems. For good seed coverage, Agrauxine Corp. generally recommends a minimum of 2.5 fl. oz. (by volume) Liquid slurry per 140k units of soybean seed, in any combination of non-chlorinated water and approved liquid seed treatments. Shake well before use. All mixed product should be used within 4 hours or less.

Application rate:
0.6 fl. oz. Per 140k units of seed.

RECOMMENDATIONS FOR ADVERSE CONDITIONS OR NEW "VIRGIN" SOYBEAN FIELDS: When any of these conditions are present, Agrauxine Corp. highly recommends at least a double (2x) rate of inoculants. ABI Sterile Peat is highly recommended to be used as a second inoculant to achieve at least a double rate.

-Soil has not hosted the specific legume for more than three (3) years • Soil pH is less than 5.8 (the pH should be adjusted by liming prior to inoculation) or Soil pH is more than 8.5 • Organic matter is less than 1.5% • Drought or flooding has occurred • Topsoil exceeds 80°F • Soil erosion • Use of soil treatments and chemicals injurious to soil bacteria and inoculants.

ATTENTION: MegaPack Inoculant is a living organism. Some seed applied chemicals may be harmful to inoculant bacteria. Check compatibility before use. It is important to protect inoculated seed from excessive heat and rapid drying.

STORAGE INSTRUCTIONS: Contains living micro-organisms. Store packaged in a cool dry place between 40°F and 77°F out of direct sunlight. Do **not** allow to freeze. Open package only when ready to use. Use product within 72 hours of opening. Close cap on the jug to minimize contamination.
