DIRECTIONS FOR USE:

This product is intended for nitrogen fixation and to improve nutrient availability.

USE PRECAUTIONS:

ATTENTION: America's Best Inoculant is a living organism. Some seed applied chemicals may be harmful to inoculant bacteria. Check compatibility before use. It is important to protect inoculated seed from excessive heat and rapid drying.

APPLICATION RATE ON SEED: 2.5 fl. oz. per 60 lbs of seed.

HOPPER BOX TREATMENT DIRECTIONS: Open box and remove cardboard insert and measuring cup. Pull bag cap through circular opening and close lid. Measure and apply the appropriate amount of America's Best Inoculant for the seed to be treated. Apply uniformly over the top of the seed and stir until all seeds are coated. For optimal performance, plant seed immediately after inoculant application.

CONTINUOUS APPLICATION DIRECTIONS:

(Auger or belt conveyor treatment) Remove bag from box and attach hose kit. Hang inoculant bag by the incorporated grommet above seed hopper and place hose end above seed flow. Adjust inoculant flow to match seed flow with the regulator attached to the hose kit.

IN-FURROW USE DIRECTIONS: Apply America's Best Inoculant at a rate of 0.5 fl. oz. per 1,000 ft. of row. Shake container well before pouring into mix tank. Dilute with clean, NON-CHLORINATED WATER and use only spray tanks and pumps that are clean and free from chemical contamination. Apply in furrow at a rate of 5 to 20 gallons diluted material per acre. Calibrate pump and spray equipment for the correct delivery rate.

RECOMMENDATIONS FOR ADVERSE

CONDITIONS OR NEW "VIRGIN" PEA/LENTIL FIELDS: When any of these conditions are present, Agrauxine Corp. highly recommends infurrow use or at least a double (2x) inoculant rate when planting legumes under the following soil conditions:• Soil has not hosted the specific legume for more than three (3) years • Soil pH is less than 5.8 (the pH should be adjusted by liming prior to inoculation) or Soil pH is more than 8.5 • Organic matter is less than 1.5% • Drought or flooding has occurred • Topsoil exceeds 80°F • Soil erosion • Use of soil treatments and chemicals injurious to soil bacteria and inoculants.

STORAGE INSTRUCTIONS: Contains living microorganisms. Store packaged in a cool dry place between 40° and 77°F out of direct sunlight. Do not allow to freeze. Open package only when ready to use. Use product within 24 hours of opening. Close cap on the bladder to minimize contamination.
