

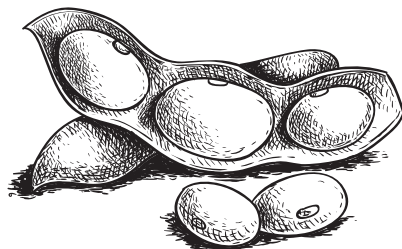

**SHAKE WELL BEFORE USING.** Use product within 24 hours of opening. This product is intended to inoculate soybeans.

#### **DIRECTIONS FOR USE:**

This product is intended for nitrogen fixation and to improve nutrient availability. America's Best Inoculant Sterile Peat may be applied to seed by the dry sprinkle method.

#### **DRY SPRINKLE METHOD:**

Cut corner off bottom of bag. Shake dry powder over seed. Stir thoroughly to ensure maximum seed coverage. Mixing is easiest when done in 140k increments. Application rate is 1.5 oz (by weight) per 140k unit of seed.

**Note:** Re-inoculate any seed not planted on same day as inoculant application to seed. Fungicidal or insecticidal seed treatments may be harmful to the bacteria. Please contact Agrauxine Corp. at 877-617-2461 for details.

#### **RECOMMENDATIONS FOR ADVERSE CONDITIONS OR NEW "VIRGIN" SOYBEANS FIELDS:**

When any of these conditions are present, Agrauxine Corp. highly recommends at least a double (2x) rate of inoculants. ABI Sterile Peat is highly recommended to be used as a second inoculant to achieve a double rate:

- Soil has not hosted the specific legume for more than three (3) years
- Soil pH is less than 5.8 (the pH should be adjusted by liming prior to inoculation) or Soil pH is more than 8.5
- Organic matter is less than 1.5%
- Drought or flooding has occurred
- Topsoil exceeds 80°F
- Soil erosion
- Use of soil treatments and chemicals injurious to soil bacteria and inoculants.

#### **STORAGE INSTRUCTIONS:**

Contains living micro-organisms. Store packaged in a cool dry place between 40° and 77°F out of direct sunlight. Do not allow to freeze. Open package only when ready to use. Use product within 24 hours of opening. Close cap on the bladder to minimize contamination.
