**DIRECTIONS FOR USE:** SabrEx for Wheat & Cereals PB is intended to improve nutrient availability in plants. SabrEx for Wheat & Cereals PB can be used for all Wheat, Sorghum, Oats, Spelt, Barley, Rye, Triticale, and Annual Grasses at the recommended usage rate. Apply as a dry seed treatment prior to planting.

**DRILL BOX APPLICATION:** Measure appropriate amount of SabrEx and sprinkle onto seed in the planter or drill box. For best results, fill planter box with seed, then add SabrEx and mix until uniform seed coverage is obtained.

**BULK APPLICATION:** Apply by manually or mechanically dispersing SabrEx into a flowing stream of seed. Ensure that SabrEx is evenly dispersed in the planter or drill box.

**APPLICATION RATE:** 1 oz. (by weight) per 100 lbs. wheat seed. 1 measuring scoop, provided, treats approximately 120 lbs. wheat seed.

Measuring scoop included. Holds approximately 1.2 oz. of SabrEx for Wheat and Cereals PB. Contents settle. Shake well before measuring by volume.
